REPORT NO: 003-17 TO: ORDINARY COUNCIL MEETING 25th JANUARY 2017 SUBJECT: PUBLIC HEALTH ACT 2016- STAGE 3 APPOINTMENT & AUTHORITY

Purpose

The purpose of this report is to advise Council that the staged implementation of the new Public Health Act 2016 requires the Shire of Ngaanyatjarraku to take responsibility for appointing Authorised Officers under the new Act from January 2017.

Background

Local governments will also become responsible for issuing authorisation cards to existing Environmental Health Officer's (EHO) and any newly employed authorised officers after January 2017. Existing employed EHO's are automatically recognised as authorised officers under the new Act however will require issuing with the new Authority cards which will require Shire delegation to the Chief Executive Officer (CEO) to allow signing and issue of the cards. As such this report will recommend that Council provide the CEO with the relevant delegations required under the new Public Health Act 2016.

Comment

Section 17 of the new Public Health Act provides Council the new ability to appoint Environmental Health Officers/Authorised Officers without the need to apply for approval from the Health Department of WA. As such Council will need to provide delegation to the CEO to carry out this new function.

Section 24 of the new Public Health Act provides Council the new ability to designate a person or class of persons as Authorised Officers and to issue authority cards to those officers. This function was previously carried out by the Health Department of WA. Council will now need to provide delegation to the CEO to carry out this new function.

Correspondence from Minister Paul Miles MLA, received 20th January 2017 regarding appointment of Approved Advisor

Purpose

The purpose of this agenda item is to appoint the Department of Local Government and Communities' Director General's approved person to ensure matters raised in the Show Cause notice are attended to by the Shire.

Also, to amend the Council's 2016/17 annual budget to allow for up \$80,000 in remuneration plus expenses (incorporating travel, accommodation and other relevant expenditure to the role) to fund this appointment for an initial period of 6 months from the date of this meeting.

Background

On the 6th January 2017 the Minister for Local Government (the Minister) issued the Shire with a "Show Cause Notice" that required the Council to take remedial action to action to address the Shire's failure to meet a number of statutory and legislative compliance requirements.

At a Special Meeting of Council on 11 January 2017, Council resolved as follows:

1) That Council resolves to accept the substance of the concerns raised in the Show Cause Notice without reservation, and commits to engaging in a remedial action pathway put in

- place at the Minister's direction by the Department of Local Government in order address the issues and assist the Shire of Ngaanyatjarraku; and
- 2) The Council's response to the Minister's letter and notice be prepared and forwarded at the earliest opportunity.

On the 20th January 2017 the Minister, advised that he had accepted the Shire's response and that accordingly he would not be issuing orders under s.8(15) the Local Government Act. Furthermore, the advice included information that Mr. John Thurtell had been recommended for appointment as the "Approved Advisor" by the Director General to ensure the matters raised in the show cause notice were attended to by the Shire.

Comments

Mr. Thurtell's appointment is somewhat open ended, in that he will remain in place until the Shire has addressed all issues in the action plan as required by the Show Cause notice. In email correspondence, the Minister's Chief of Staff indicated that a period of 18-24 months could possibly be anticipated.

The proposal before this meeting of Council is for funding for the position for the initial 6 months; any possible further extension of the appointment would be incorporated into future annual budgets.
