- (3) The information in a Statement of Financial Activity may be shown-
 - (a) according to nature and type classification;
 - (b) by program; or
 - (c) by business unit.
- (4) A Statement of Financial Activity and the accompanying documents referred to in subregulation (2), are to be



- (a) presented to the Council
 - (i) at the next ordinary meeting of the Council following the end of the month to which the Statement relates; or
 - (ii) if the Statement is not prepared in time to present it to the meeting referred to in subparagraph (i), to the next ordinary meeting of the Council after that meeting:

and

- (b) recorded in the minutes of the meeting at which it is presented.
- (5) Each financial year, a local government is to adopt a percentage or value, calculated in accordance with AAS 5, to be used in Statements of Financial Activity for reporting material variances.
- (6) In this regulation –

"committed assets" means revenue unspent but set aside under the annual budget for a specific purpose;

"restricted assets" has the same meaning as in AAS 27.

PURPOSE OF REPORT

The purpose of this report is to present to Council the Local Government Statutory Compliance Audit Return for 2014 for the Shire of Ngaanyatjarraku.

BACKGROUND

The Department of Local Government & Communities has issued Circular No. 35-2014, which requires each local government in Western Australia to carry out a Compliance Audit in relation to the period 1 January to 31 December 2014, against the requirements set out in the 2014 Compliance Audit Return ('CAR').

Section 7.13(1)(i) of the Local Government Act 1995 contains provisions for the making of regulations requiring local governments to carry out, in the manner and form prescribed, an audit of compliance, whether of a financial nature or not.

The Local Government (Audit) Regulations 1996, detail the following in relation to the CAR process:

Regulation 13 – Prescribed statutory requirements for which compliance audit needed (Act s. 7.13(1)(i))

For the purposes of Section 7.13(1)(i), the statutory requirements set forth in the Table to this regulation are prescribed..

Regulation 14 – Compliance Audits by Local Governments

- (1) A local government is to carry out a compliance audit for the period 1 January to 31 December in each year.
- (2) After carrying out a compliance audit the local government is to prepare a compliance audit return in a form approved by the Minister.
- (3A) The local government's audit committee is to review the compliance audit return and is to report to the council the results of that review.
- (3) After the audit committee has reported to the council under subregulation (3A), the compliance audit return is to be—
 - (a) presented to the council at a meeting of the council; and
 - (b) adopted by the council; and



(c) recorded in the minutes of the meeting at which it is adopted.

Regulation 15 - Compliance audit return, certified copy of etc. to be given to Executive Director

- 1. After the Compliance Audit Return has been presented to the Council, in accordance with Regulation 14(3), a certified copy of the return, together with
 - (a) a copy of the relevant section of the minutes referred to in Regulation 14(3)(c); and
 - (b) any additional information explaining or qualifying the compliance audit;

is to be submitted to the Executive Director by 31 March next following the period to which the return relates.

2. In this Regulation –

"certified" in relation to a compliance audit return means signed by -

- (a) the Mayor or President; and
- (b) the Chief Executive Officer.

COMMENT

The completed 2014 Compliance Audit Return document is summarised below by each category:

Section (a) Commercial Enterprises by Local Government

The 5 areas of compliance are not applicable to the Shire of Ngaanyatjarraku.

Section (b) Delegation of Power/Duty

All 13 areas of compliance were met.

Section (c) Disclosure of Interest

All 16 areas of compliance in this category were either met or deemed not applicable in the Shire's circumstances.

Section (d) Disposal of Property

The 2 compliance areas in this section were not applicable to the Shire.

Section (e) Elections

The 1 area of compliance was not applicable, as listed in the CAR document.

Section (f) Finance

10 out of the 15 areas of compliance were met (or not applicable); the 5 areas of non-compliance relate to the finalization and completion of Council's 2013-14 Audit and receipt of the associated Auditor's report. Explanatory comments for this have been provided in the CAR by the CEO.

Section (g) Local Government Employees

The 5 areas of compliance in this category were deemed compliant or not applicable, as no significant changes were made to senior employee positions or personnel during the year.





Section (h) Official Conduct

The 6 areas of compliance were met or not applicable.

PURPOSE OF REPORT

The purpose of this report is to amend the existing Shire delegations in relation to the issuing of Building Permits and related matters.

BACKGROUND

There have been significant legislative changes since adoption of the Building Regulations 2012 when the new building permit system was introduced in Western Australia. The Shire of Ngaanyatjarraku has for many years utilised the services of the City of Canning under contract to the Shire to provide Building Surveyor services. The legislative changes require that a local government employee, under delegated authority, issues building permits after the issue of Certificates of Design Compliance (CDC) issued by a building surveyor. Whilst Mr Paul Todd, as a qualified building surveyor, has been able to issue permits for the Shire other staff at the City of Canning have advised that they will not issue CDC's for the Shire and will only accept what are termed certified applications. This means that CDC's need to be issued by a Contractor for all applications, prior to the issuing of permits. This will result in substantially higher fees for local applicants for the more rudimentary structures constructed in the lands (carports and single dwellings). Furthermore the current contract with the City of Canning is due to expire on the 30 June and the Shire needs to retain the ability to issue permits itself irrespective of future contract negotiations or alternative service arrangements.

COMMENTS

Mr Paul Todd, as a qualified Building Surveyor, has provided the ability for the Shire to issue Building Permits. The Shire needs to establish suitable arrangements for the issuing of building permits and to ensure compliance with the Building Act and Regulations, given the impending end of the current contract with the City of Canning. Paul Todd will be able to undertake the necessary production of Certificates of Design Compliance, such that the CEO can issue Building Permits, however the existing (to July 2015) and future contractual arrangements are yet to be finalised.

By allowing delegation to the CEO other building matters can also be managed by the Shire as they arise, such as demolition permits. To establish these arrangements it is necessary that suitable delegations be adopted, in accordance with the Building Act 2011, the Building Regulations 2012 and the Local Government Act 1995.

It should be noted that an officer must have the prescribed qualifications to be delegated authority to approve or refuse plans of buildings or unauthorised building works. Where plans are approved a



Building Surveyor issues a Certificate of Design Compliance. This is the work currently undertaken by Mr Paul Todd, Building Surveyor. The actual issue of permits and some other matters are administrative functions, the delegation for which can be made to the CEO. The delegations made to the CEO will enable the existing contractual arrangements to continue until their finality, whilst enabling the Shire to issue Building Permits.

Statutory Environment

The Building Act 2011 and the Building Regulations 2012 control the issuing of building permits, the management of building activities, demolition permits and various activities including the management of incomplete and dilapidated buildings and the inspection of buildings, including swimming pools.

The Building Services (Registration) Regulations 2011 establish qualification requirements for those assessing plans (Building Surveyors). The Local Government Act 1995 establishes requirements for the delegation of responsibilities under the Act and related legislation for Local Government CEO's, including the capacity for on delegation by that individual. This ability for the CEO to on delegate to an employee is retained under the Building legislation in most circumstances and the CEO can determine to what extent the powers are delegated to another individual or a Building Surveyor. The Shire can establish delegations to enable the management of building issues irrespective of who issues the Certificate of Design Compliance.

Policy Implications

New Delegations to be established in accordance with the Building Act 2011 and the Local Government Act 1995

Financial Implications

Standard fees and charges apply to applications for building permits. The costs, borne predominantly by the Shire with respect to payment for Mt Todd's services will remain unchanged. The issuing of Certificates of Design Compliance and permits under the new legislation is more time consuming and hence a typical application will take 1.5 - 4 hours to complete whereas the previous legislation enabled issue within 1-3 hours depending upon the complexity of the project. Irrespective of this Paul Todd will continue to issue the CDC's for the Shire, pending negotiations around the current contract with the City of Canning.

Strategic Implications

Consultation

No specific consultation is required by the Shire in this instance. Discussions with Management at the City of Canning have confirmed that it is good practice for the delegations to be in place to the CEO of a local government to ensure that permit services can be maintained at any time.


