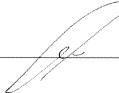

REPORT NO: 038-14 TO: ORDINARY COUNCIL MEETING 24th SEPTEMBER 2014 SUBJECT: FINANCIAL STATEMENTS FOR THE PERIOD ENDING 31st AUGUST 2014

Regulation 34 of the Local Government (Financial Management) Regulations 1996 requires the following in relation to the Financial Activity Statement:

- (1) A local government is to prepare each month a statement of financial activity reporting on the sources and applications of funds, as set out in the annual budget under regulation 22(1)(d), for that month in the following detail-
 - (a) annual budget estimates, taking into account any expenditure incurred for an additional purpose under section 6.8.
 - (b) budget estimates to the end of the month to which the statement relates;
 - (c) actual amounts of expenditure, revenue and income to the end of the month to which the statement relates;
 - (d) material variances between the comparable amounts referred to in paragraphs (b) and (c); and
 - (e) the net current assets at the end of the month to which the statement relates.
- (2) Each Statement of Financial Activity to is to be accompanied by documents containing-
 - (a) an explanation of the composition of the net current assets of the month to which the statement relates, less committed assets and restricted assets;
 - (b) an explanation of each of the material variances referred to in subregulation (1)(d); and
 - (c) such other supporting information as is considered relevant by the local government.
- (3) The information in a Statement of Financial Activity may be shown-
 - (a) according to nature and type classification;
 - (b) by program; or
 - (c) by business unit.
- (4) A Statement of Financial Activity and the accompanying documents referred to in subregulation (2), are to be

(a) presented to the Council –

- (i) at the next ordinary meeting of the Council following the end of the month to which the Statement relates; or
- (ii) if the Statement is not prepared in time to present it to the meeting referred to in subparagraph (i), to the next ordinary meeting of the Council after that meeting;

and

- (b) recorded in the minutes of the meeting at which it is presented.
- (5) Each financial year, a local government is to adopt a percentage or value, calculated in accordance with AAS 5, to be used in Statements of Financial Activity for reporting material variances.
- (6) In this regulation –

"committed assets" means revenue unspent but set aside under the annual budget for a specific purpose;

"restricted assets" has the same meaning as in AAS 27.

Draft Terms of Reference – Local Government Planning Committee on Municipal Services

BACKGROUND

As Members would be aware, the issue of delivering municipal services to remote indigenous communities and responsibility for these has been discussed by the Australian Federal Government and Western Australian Governments since 2007/08. These bilateral talks have often not involved or engaged local governments in this State, nor our representative body in WALGA.

Local Government has often been touted as the party through which such services will ultimately be provided to indigenous communities, however there have been numerous policy changes and deadlines which have passed without any decisions being made. We have been involved in extensive scoping and costing exercises and consultations to assist with the process, but all of this information seems to have not moved the process on very far – causing much frustration for Local Governments and the communities alike.

Recently the Federal Minister for Indigenous Affairs, Sen. Nigel Scullion, announced that the Commonwealth would effectively be withdrawing from funding involvement in municipal services delivery and handing over responsibility to the State Government. The Department of Local Government & Communities will be involved in consulting, planning and liaising with Councils towards a joint approach to ongoing service provision – but it needs to be noted that as no details on likely funding arrangements have been determined, and many other issues including land tenure, community/town planning and infrastructure asset ownership are yet to be resolved, many Councils across the state are at this stage refusing to become involved.

The Director General of the Department is proposing to re-establish a Planning Committee which was originally started in 2010 and involved representatives from WALGA, LGMA, local governments and the relevant State and Commonwealth Government departments. The Shire of Ngaanyatjarraku, along with our affected counterparts across WA, has been asked to nominate representatives for this Committee; the nominees can be either Council Members or the CEO.
